This letter is to confirm that the monitor well (MW-1) at Rice Operating Company's Hobbs A-6 Vent project has been properly plugged and abandoned with grout containing 1-3% bentonite/concrete slurry and a 3 foot concrete cap per NMOCD requirements. Please find attached the driller's report and photographs of this work.

ROC acknowledges they have met the requirements in accordance of 19.15.29 NMAC (Part 29; formally Rule 16), and the remediation plan (1R428-59) is terminated in accordance with 19.15.29 NMAC and no further action is required.





WINDMILL


