

Downhole Commingling Application

Allocation Formula

The Glade Park #1 is an existing Basin Fruitland Coal well and a proposed W. Kutz Fruitland Sand Ext. well. The Fruitland Coal formation was first delivered in September of 2012. The production has stabilized at approximately 68 MCF/D with very little water and no liquid hydrocarbon production (See attached rate - time graph).

The W. Kutz Fruitland Sand pool lies to the east of the Glade Park #1 with the closest well being in Sections 23 of T29N, R13W. The Fruitland Sand wells have a typical decline curve for a sandstone gas expansion reservoir (peak production early with a hyperbolic decline, then a steady exponential decline after a few years).

Since the Fruitland Sand formation has not been completed, it is proposed to assign the first 68 MCFD to the Basin Fruitland Coal formation and the remainder to the W. Kutz Fruitland Sand formation. After the total production from the well declines to 68 MCFD, the production will be allocated 50:50 between the two zones. Neither zone is expected to make any appreciable amount of liquid hydrocarbons.

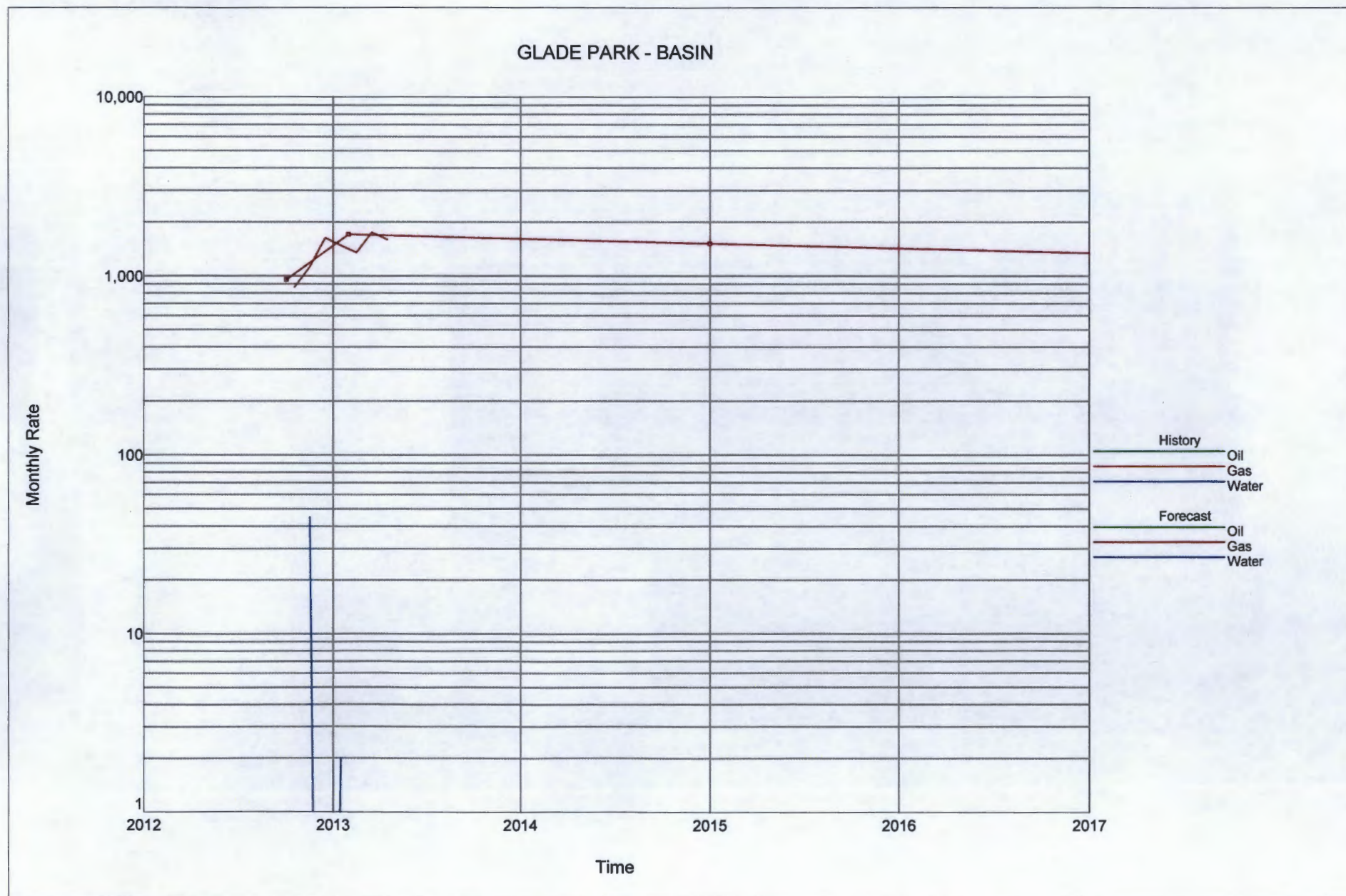
