Dear Oil Conservation Division Associate,

Enclosed is our application for surface commingling (application) for the two referenced gas wells. We are respectfully asking for your approval of our application for economic reason. The two referenced gas wells are currently producing and selling gas utilizing two-individual gas compressors. The costs associated with leasing, maintaining, repairing, and replacing the two gas compressors has brought these Wells to their economic limits.

We are proposing to surface commingle gas from these two wells utilizing one of the existing compressors to compress gas for both wells. This proposed action will

significantly reduce lease operating expenses for both Wells keeping the Wells economic for the time being.


We propose utilizing the gas compressor currently located on the River Rat #1 location as the sole gas compressor for both wells. We propose using the existing River Rat #1 gas meter as the combined gas meter for both Wells and the existing McDaniel #1 gas meter to measure gas production solely from the McDaniel #1. We propose to allocate gas production to the River Rat #1 using a subtraction method of the combined gas meter totals less the McDaniel #1 gas meter total. We will account for the difference in BTU value between the two gas Wells and allocate the correct MMBTU/day to each Well.






