

Lynx Petroleum Consultants, Inc. is applying to the New Mexico Oil Conservation Division for authority to surface commingle gas produced from the Eddy 'BD' State well numbers 2 and 3 into a single DCP sales meter. The Eddy 'BD' State number 2 currently produces gas from the Golden Lane Morrow, pool code 77560. The number 3 well is producing from the Wildcat Wolfcamp, pool code 97963.

The reason for this proposed change in operation is that the number 2 wellbore will no longer produce reliably into the high pressure (500 psig) Enterprise gas connection. The number 3 wellbore is connected to a DCP line where pressures are substantially lower at around 150 psig. Economics favor a connection into the low pressure line rather than the installation of compression. The current orifice check meter located at the number 2 tank battery will be now be utilized as an allocation meter and all gas produced from the number 2 well will be continuously measured. Ownership of the interests in both wellbores is common.


