SUBJECT: REQUEST FOR UNORTHODOX LOCATION FOR RUBY FEDERAL #31

Dear Sirs,

ConocoPhillips Company respectfully requests a non-standard location exception to drill the Ruby Federal #31 well. The lease is recorded as NM LC 029405B. The well is located in UL H, 2155' from the north line and 200' from the east line of Section 18, Township 17S, Range 32E, Lea County, New Mexico. The footages place the well closer than 330' from a Qtr/Qtr Section line. This location was found to be the only one suitable for this well, that would allow us to reach our targeted production zone, while still protecting sand dune habitat deemed critical by the Bureau of Land Management biologist. ConocoPhillips is 100% lessee and 100% working interest owner of the Ruby federal lease. The spacing units adjacent to UL H (A, B, G, J, I and E in Section 17) are also ConocoPhillips Ruby lease, 100% working interest. The granting of this exception will prevent waste and minimize surface disturbance.
