Per our phone conversation on October 31, 2013, LOGOS Operating, LLC respectfully requests the amendment of NSL locations for the following wells:

- Logos 7- Order No. NSL-6868-0 ✓
- Logos 8- Order No. NSL-6869-0
- Logos 9- Order No. NSL-6971-0
- Logos 12- Order No. NSL-6970-0

While the letters of application for the NSL on these wells did originally mention the Gallup as well as the Dakota formations, no C-102 for the Gallup Pool was included and as such these NSLs were granted only for the Dakota. These wells were originally permitted as Dakota wells, however, at this time we have decided not to complete the Dakota formation, and to complete the Gallup formation instead. As such, we request the amendment of these orders from Dakota NSLs to Gallup NSLs.

Please note that the ownership of all formations in these lands and the affected lands is the exact same. As such, we believe no additional notice is required. I have also attached C-102s for the Gallup for all of these wells to the email to which this letter is attached.


