Mack Energy Corporation is requesting administrative approval from the NMOCD for approval of surface commingling of production from our Deep Jack #1 Lease(E-5014-6) and Black Jack State Lease(VB-1313). Production from the WC-025 G-06 S183518A, Bone Spring will be commingled at Black Jack State #1 Tank Battery located in the NE/4 SE/4 Sec. 18 T18S R35E. The Black Jack State #1 is currently producing and we are scheduled to drill the Deep Jack #1 this month.






The working interests in these two leases are identical, but the net revenue interests are different due to an override and the royalty interests. See the attached lists.
