COG Operating, LLC, requests an amendment to the Division Order No. CTB-673 to remove the Grave Digger Federal Com. Well No. 1H (30-015-37665) from the order, and add certain wells to the order. This requested amendment is approved, and COG Operating LLC (OGRID 229637) is hereby authorized to surface commingle oil and gas production from North Seven Rivers; Glorieta-Yeso Pool (**97565**) from the following leases and wells:

Further, the Grave Digger Federal Com. Well No. 1H (API30-015-37665) is hereby removed from the original order.

The commingled oil and gas production from the wells detailed above shall be measured and sold at the Grave Digger State Com Well No. 3H central tank battery (CTB), located in Unit B, Section 2, Township 20 South, Range 25 East, NMPM, Eddy County, New Mexico.

The oil and gas production from each well shall be continuously measured with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

The installation shall be installed and operated in accordance with applicable Division rules. It is the responsibility of the producer to notify the transporter of this commingling authority.


