On behalf of Logos Resources LLC ("Logos") and pursuant to Division Rule 19.15.15.11.B(2) (a) and (b) and the applicable rules governing the acreage and well location requirements for the Basin-Mancos Gas Pool (97232; Order No. R-12984), we request administrative approval for a 40 acre  $\pm$  non-standard oil spacing and proration unit comprised of the SW/4 SE/4 of Section 4, Township 23 North, Range 8 West, NMPM.

Logos seeks an exception from the applicable acreage dedication and well location rules for the following reasons: Order No. R-12984 established special pool rules for the Basin-Mancos Pool as a gas pool with 320 acre spacing units and well location setbacks of 660'. The special pool rules also provide that oil wells located within two miles of certain Gallup oil pools or associated pools identified in Order No. R-12984 are to be drilled and spaced in accordance with the rules applicable to those pools. The spacing unit proposed in this case is located in close proximity to the

Nageezi - Gallup Oil Pool (47540) and the well is expected to produce oil from a correlative stratum. The current rules for that pool reflect statewide rules and provide that wells shall be located no closer than 330' to the boundary of a unit, with 40-acre units dedicated to the wells. However, this pool is not among the pools specified in Order No. R-12984 and therefore, the Division has previously advised that the rules for the pool may not be extended to the proposed spacing unit and well location. Therefore, this application for exception is made necessary.

This proposed well is no closer than 330' to the outer boundary of the SW/4 SE/4 of the section and otherwise complies with statewide acreage dedication and locational rules applicable to oil wells. The unit and well location are also consistent with the established development pattern for Mancos oil wells in the area. In this regard, please note that the Division has previously approved a non-standard location and a non-standard proration unit for a Basin-Mancos oil well drilled by Logos in Unit P immediately adjoining the subject unit. (See Orders NSL-6753 and NSR-1961.) The the C-102 plat and area APD Map showing the SW/4 SE/4 spacing unit and the proposed location for the Heros Well No. 4-O are attached as Exhibits A and B.

Logos Resources LLC owns and operates all of Section 4 T23N R8W under a single federal lease (NMNM-109398). Royalty and overriding royalty interests in the S/2 of Section 4, including the SW/4 SE/4 of the section are uniform. The Bureau of Land Management is being notified of this application, but no further notification is indicated under Division Rules 19.15.4.12 A(2) and (3) (Exhibit C).

The Division's Administrative Application Checklist is enclosed.

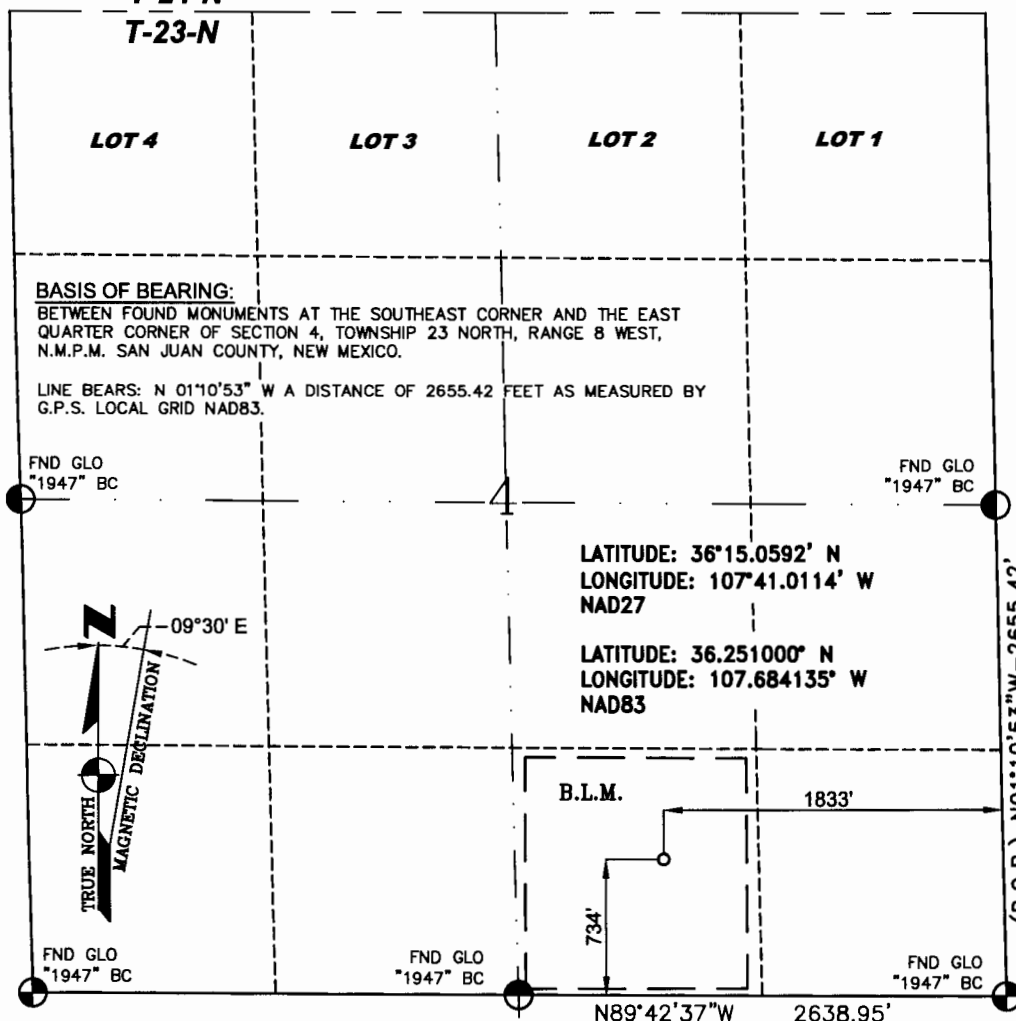

Both engineering and geologic. The locations conform to an existing development pattern in the area and one oil well at a gas well location won't efficiently recover all the reserves in the 40-acre unit. The locations are also necessary to protect from drainage from an offsetting well in Section 9 located less than 660' off the section line and these locations are prospective for production from the same stratum.
