



EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Ramblin Rose 23 Fed 4H Well** to be completed within the Jennings; Bone Spring, West Pool (Pool Code 97860) underlying Section 14, Township 26 South, Range 31 East, N.M.P.M., Eddy County, New Mexico. This well will be drilled from a surface location 450 feet from the North line and 915 feet from the West line of Section 23. The upper most perforation will be located 50 feet from the South line and 879 feet from the West line (Unit M) of Section 14 and the lower most perforation will be 330 feet from the North line and 880 feet from the West line of Section 14 (Unit D). Since this acreage is governed by the Division's statewide rules which provides for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the southern boundary of the project area. Approval of the unorthodox completed interval will prevent waste of a productive portion of the reservoir and improve well performance.

Exhibit A is the Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Ramblin Rose 23 Fed 4H Well** encroaches on the spacing and proration units to the South and Southeast.

Exhibit B is a land plat for Section 14 and the surrounding sections that shows the proposed **Ramblin Rose 23 Fed 4H Well** in relation to adjoining units and existing wells.

EOG is the sole operator and mineral lessee of the federal lease covering Section 23. Accordingly, there are no affected parties by the encroachment to the South and Southeast. Nonetheless, a copy of this application has been provided to the Bureau of Land Management.




