Mack Energy Corporation as operator respectfully requests administrative approval to surface commingle and measurement of production. It is requested that surface commingling of Paddock South, Blinebry and Brunson; Drinkard-Abo South pools be approved for the following lease: State BD 36 (VB-2157) Sec. 36, T22S, R37E

The tank battery is located in the NW/4 SE/4, Sec. 36 T22S R37E. Proper allocation for production will be measured using periodic well tests. Mack Energy has made notification to all parties owning an interest in this lease, including the oil purchaser, of the intent to commingle. Interests in all pools on this lease are common.

Mack Energy is currently producing the State BD 36 #2 in the Paddock South and intend to down hole commingle in the Blinebry when DHC order is approved. State BD 36 #3 will be completed in the Brunson; Drinkard-Abo South Formation. At this time we are requesting approval to add the Blinebry and Brunson; Drinkard-Abo South to this production.
