WPX Energy Production, LLC (OGRID 120782) owns 100% of the interest in the state lease for Section 2, Township 22 North, Range 6 West, NMPM, Sandoval County, New Mexico. WPX drilled the Chaco 2206-02H 272H well as a horizontal well within the Lybrook Gallup Oil Pool (42289) from a surface location of 1707 feet from the North line and 335 feet from the East line. The point of entry into the Lybrook Gallup Oil Pool is at 2690 feet from the North line and 400 feet from the East line (Unit H). The well has been perforated at 2720 feet from the North line and 858 feet from the East line (Unit I), 2716 feet from the North line and 1361 feet from the East line (Unit J), 2639 feet from the North line and 430 feet from the East line (Unit G), 2634 feet from the North line and 2107 feet from the West line (Unit F), and 2649 feet from the North line and 660 feet from the West line (Unit E).

A project area is the area an operator designates on form C-102, well location and acreage dedication plat that comprises one or more complete, contiguous spacing units (in one section or more than one section) that are developed by the horizontal well. 19.15.16.7.L(1) NMAC.

The project area for the Chaco 2206-02H 272H is non-standard because it does not meet the definition of a standard project area as set forth in 19.15.16.7.M NMAC. Approval of a non-standard project area is necessary because while WPX was building the curve they encountered difficulty getting the tool landed at the azimuth originally planned, instead landing the tool six degrees (6°) from the targeted two hundred seventy-one degrees (271°). When WPX began drilling the lateral portion of the wellbore they worked to bring the azimuth back to the planned location but it took a greater distance than anticipated, therefore penetrating spacing units I and J.

## HOLLAND&HART

The Lybrook Gallup Oil Pool is spaced pursuant to statewide rule 19.15.15.9.A NMAC. That rule provides for 40-acre spacing and requires that the well remain 330 feet from the outer boundary of the spacing unit. *Id.* Previously, the Division approved an unorthodox well location for the Chaco 2206-02H 272H. *See* Administrative Order NSL-7023. WPX seeks amendment of Administrative Order NSL-7023 to reflect a penetration point at 2690 feet from the North line and 400 feet from the East line and a terminus at 2662 feet from the North line and 228 feet from the West line of Section 2.

Accordingly, WPX respectfully requests the Division grant the following relief:

- (1) Pursuant to 19.15.16.15.E NMAC, approve a non-standard 240-acre project area comprised of the N/2 SE/4 (Units I and J) and S/2 N/2 (Units H, G, F, E) of Section 2, Township 22 North and Range 6 West, Sandoval County, New Mexico;
- (2) Pursuant to 19.15.15.13.C NMAC, amend Administrative Order NSL-7023 to approve a non-standard horizontal well location with a penetration point of 2690 feet from the North line and 400 feet from the East line and a terminus at 2662 feet from the North line and 228 feet from the West line of Section 2.

As further support for this application, WPX has provided the following exhibits with this letter:

**Exhibit A** is the Well Location and Acreage Dedication Plat (Form C-102), which shows the non-standard project area and the Chaco 2206-02H 272H well encroachment on the spacing and proration units to the South and Southwest of the S/2 NW/4 of Section 2.

**Exhibit B** is a list of the affected parties for the request to amend Administrative Order NSL-7023. A copy of this application with all attachments has been sent by certified mail to each of these affected parties advising them that if they have an objection they must file it in writing with the Division within 20 days from the date the Division receives this application.

**Exhibit C** is a copy of the letter provided to the New Mexico State Land Office of the non-standard project area as required by 19.15.16.15.E(1) NMAC.


