Apache Corporation (OGRID 873) is hereby authorized to surface commingle oil and gas production from Fren; Glorieta-Yeso (26770). These wells are identified in Attachment A, and made part of this order. These wells are located on federal leases in said Township and Range in Eddy County, New Mexico.

The commingled oil and gas production from the wells detailed above shall be measured and sold at the Crow Federal Well No. 1 central tank battery (CTB) located in Unit A, Section 9, Township 17 South, Range 31 East, NMPM, Eddy County, New Mexico.

The oil and gas production from each well shall be continuously measured with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.


This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.

This approval is subject to like approval from the United States Bureau of Land Management before commencement of the commingling operations.
