Dear Mr. McMillan:

ConocoPhillips Company respectfully requests a non-standard location exception to produce the Wilder 28 AC Federal COM #8H (API# 30-025-41692). The surface hole location is on the NM27058 lease in UL D, 280' FNL & 330' FWL of Section 28, Township 26S, Range 32E, Lea County, New Mexico. The bottom hole location is on lease serial number NMNM130738 in Lot 4, 771' FSL & 1002' FWL of Section 33, Township 26S, Range 32E, Lea County, New Mexico. The bottom hole location is greater than 330' from the state line.

The first take point footages that are in UL D, 777' FNL & 1021' FWL of Section 28 Township 26S Range 32E. and last take point footages that are in Lot 4, 1603' FNL & 1010' FWL of Section 33 Township 26S Range 32E, place the producing interval closer than 330' from a Qtr/Qtr Section lines. The table below details the operators of adjacent spacing units.

ConocoPhillips Company has respectfully requested a non-standard location exception to produce the Wilder 28 AC Federal COM #8H (API# 30-025-41692). The surface hole location is on the NM27058 lease in UL D, 280' FNL & 330' FWL of Section 28, Township 26S, Range 32E, Lea County, New Mexico. The bottom hole location is on lease serial number NMNM130738 in Lot 4, 1869' FNL & 1002' FWL of Section 33, Township 26S, Range 32E, Lea County, New Mexico.

This letter serves to provide additional information the Engineering Bureau requires to approve our exception request. Our perforation interval is 9556'-15,662' MD. This interval is in Section 28, UL D, E, L, M and Section 33 UL D & Lot 4. The producing interval top is 777' FNL & 1021' FWL of Section 28 Township 26S Range 32E. The producing interval bottom is 1603' FNL & 1010' FWL of Section 33 Township 26S Range 32E.

The granting of this exception will prevent waste and minimize surface disturbance.

This location was found to be the only one suitable for this well, that would allow us to reach our targeted production zone.
