Attached is a C-107A Application to downhole commingle the Blinebry Oil & Gas (Oil-06660), Drinkard (19190), and Wantz-Abo (62700) Pools within Quantum's Encore M State Well No. 8.

The Encore M State Well No. 8 was drilled in June, 2013 and was completed in the Drinkard and Abo formations. At the time the well was completed, Quantum obtained approval from the OCD Hobbs District Office to downhole commingle the Drinkard and Wantz-Abo Pools within the well. Pursuant to Order No. DHC-HOB-519, 50% of the oil and gas was to be allocated each to the Drinkard and Wantz-Abo Pools.

Quantum is now proposing to complete the Blinebry Oil and Gas Pool within the subject well through perforations from 5,518 feet to 5,676 feet. Consequently, Quantum seeks approval to downhole commingle all three pools within the well.

The 2014 average producing rate of the Drinkard and Wantz-Abo Pools within the Encore M State No. 8 is 9.5 BOPD, 26 MCFGPD and 15 BWPD.

Based upon the current producing rate of the Drinkard and Wantz-Abo Pools within the Encore M State No. 8, and based upon the 2014 average Blinebry producing rate of several offset wells in this area (**See Attached Table**), Quantum estimates that the Blinebry Oil and Gas Pool within the subject well will produce approximately 9-12 BOPD, 26-61 MCFGPD and 15-48 BWPD.

Consequently, Quantum requests that the production from the Encore M State No. 8 be allocated as follows:
