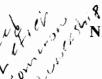

This Downhole Commingle is part of a record clean up. XTO Energy Inc. discovered during well file review that well completion records filed by the original operator (Texacoma Oil & Gas Corp.) are not complete. This well was DHC in 2003 and appropriate fillings were not made at that time. XTO assumed operation in 2008. XTO inactivated this well in 2010. XTO is working to get the paperwork straightened out to have the proper approvals in place. The Texakoma 7 #2 which consists of the Flora Vista Fruitland Sand and the Basin Fruitland Coal are not in pre-approved pools. The ownership between the two zones is in fact common. If there is anything else that I can help you with to get this going let me know. Let me know if I need to do anything with the bottomhole pressures.

- Have you notified the affected parties, if none get a landman to state common ownership.
- You will need to provide a bottomhole pressure for the lower zone. You will need evidence to demonstrate that
 commingling will not result in shut-in or flowing well bore pressures in excess of any commingled pool's fracture
 parting pressure.
