Well: Glycerin 10 Federal Com. Well No. 1H

Lease: Federal Com. NMNM 124739

Description: S/2 N/2 of Section 10, Township 16 South, Range 29 East, NMPM

Well: Glycerin 10 Federal Com. Well No. 2H

The combined project area for these wells include the N/2 of Section 10, Township 16 South, Range 29 East, NMPM, Eddy County, New Mexico.

The commingled oil and gas production from the wells detailed above shall be measured and sold at the Glycerin 10 Federal Com. Well No. 1H Central Tank Battery (CTB), located in Unit A, Section 10, Township 16 South, Range 29 East, NMPM, Eddy County, New Mexico.

Production from the subject wells shall be determined as follows:

The oil and gas production from each of the diversely-owned leases shall be separately metered using allocation meters.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2).

Subsequently drilled wells that produce from the subject pool within the project areas approved by this order may be added to this commingling authority by submittal of a Sundry Notice to the Engineering Bureau in Santa Fe.
