

Re: Application of Tap Rock Operating, LLC for administrative approval of a 128.4-acre non-standard spacing and proration unit in the E/2 of Irregular Section 36, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico.

Dear Mr. Catanach:

Pursuant to Rule 3 of the Special Rules for the Purple Sage-Wolfcamp Gas Pool and NMAC 19.15.15.11.B(2), Tap Rock Operating, LLC ("Tap Rock") (OGRID No. 372043) seeks administrative approval of a 128.4-acre non-standard gas spacing and proration unit comprised of the E/2 of Irregular Section 36, Township 26 South, Range 30 East, NMPM, Eddy County, New Mexico. The proposed non-standard spacing and proration unit will be dedicated to the **Nailed It State Com No. 1**, a vertical well to be drilled 330 feet from the South line, 990 feet from the East line (Lot 1) of Irregular Section 36.

The **Nailed It State Com No. 1** will develop the Wolfcamp formation (Purple Sage; Wolfcamp Gas Pool (98220)). Pursuant to the Special Rules for the Purple Sage-Wolfcamp Gas Pool, set forth in Order No. R-14262, wells within the Purple Sage Pool must be spaced on 320-acres. Rule 3 of the Special Rules for Order R-14262 permit exceptions as allowed in Division rules. The Division rules, 19.15.15.11.B(2) authorize administrative approval of non-standard spacing units when the non-standard spacing unit consists of a single quarter-quarter section or lot or quarter-quarter sections or lots joined by a common side and the non-standard spacing unit lies wholly within a single half section if the well is in a pool for which 320 acres is the standard spacing unit size.¹ The proposed non-standard spacing unit consists of adjoining lots and is located wholly within a single half-section.

¹ Section 36 is an irregular correction section bordering Texas. The proposed non-standard spacing unit is not less than 70 percent of the size of a standard spacing unit and therefore does not require approval due to the variation in the legal subdivision of the public lands survey.



Tap Rock seeks approval of this non-standard spacing unit to most efficiently develop the Wolfcamp in this area. All interest owners in the E/2 also own working interests in the W/2 of Irregular Section 36, though the ownership percentage is not identical. The interest owners have previously been made aware of Tap Rock's proposed development plan in the E/2 of Irregular Section 36. Tap Rock intends to further develop its acreage in both the E/2 and the W/2 of Irregular Section 36 with stand-up horizontal wells.

Exhibit A is a copy of the Well Location and Acreage Dedication Plat (Form C-102) for the **Nailed It State Com No. 1**.

Exhibit B is a copy showing the proposed vertical well and the proposed spacing unit in the E/2 of Irregular Section 36, marked as Tract 1 and highlighted in yellow. Tract 2 is the area affected by the administrative application. Outlined in red in Chevron's ownership percent in each spacing unit. The other interest owners' percentages (Tap Rock, RSC, and PT) are also noted on this exhibit. Tap Rock, RSC, and PT are signatories of a joint operating agreement covering this acreage.

Exhibit C is a list of parties in the W/2 of Irregular Section. A copy of this application with all attachments has been sent by certified mail to each affected party advising them that if they have an objection it must be filed in writing with the division within 20 days from the date the division receives this application. A courtesy copy of this application has also been provided to the State Land Office.

Your attention to this matter is appreciated.




