Devon Energy Production Company, L.P. ("Devon") respectfully requests administrative approval of an unorthodox well location for the Mean Green 23-35 Fed Com 4H to be completed in the WC-025 G-08 S263412K; BONE SPRING Pool (96672), API Number 30-025-44598. As shown on the enclosed C-102, the permitted surface location is 2,449' FSL and 920' FEL of Section 23-T26S-R34E, with a permitted bottom hole location 200' FSL and 1,133' FEL of Section 35-T26S-R34E. The projected FTP (first take point) is expected to be approximately 2,310' FSL and 1,133' FEL of Section 23-T26S-R34E, and projected LTP (last take point) is expected to be approximately 330' FSL and 1,133' FEL of Section 35-T26S-R34E. The completed interval for this well will be unorthodox because it is closer than 330 feet to the northwestern, western and southwestern boundaries of the project area. The reason for permitting this well at an unorthodox location is to maximize recovery by using Devon's preferred well spacing for horizontal wells.

Please be advised the parties named on "list of affected parties" own 100% of the leasehold in Sections 23, 26 and 35-26S-34E; therefore, notice is not required. All parties listed have been sent a courtesy copy of this application. In addition, notification is not required to the offsetting operator/leaseholder to the southwest (Tract 4) due to the acreage being located in Texas.

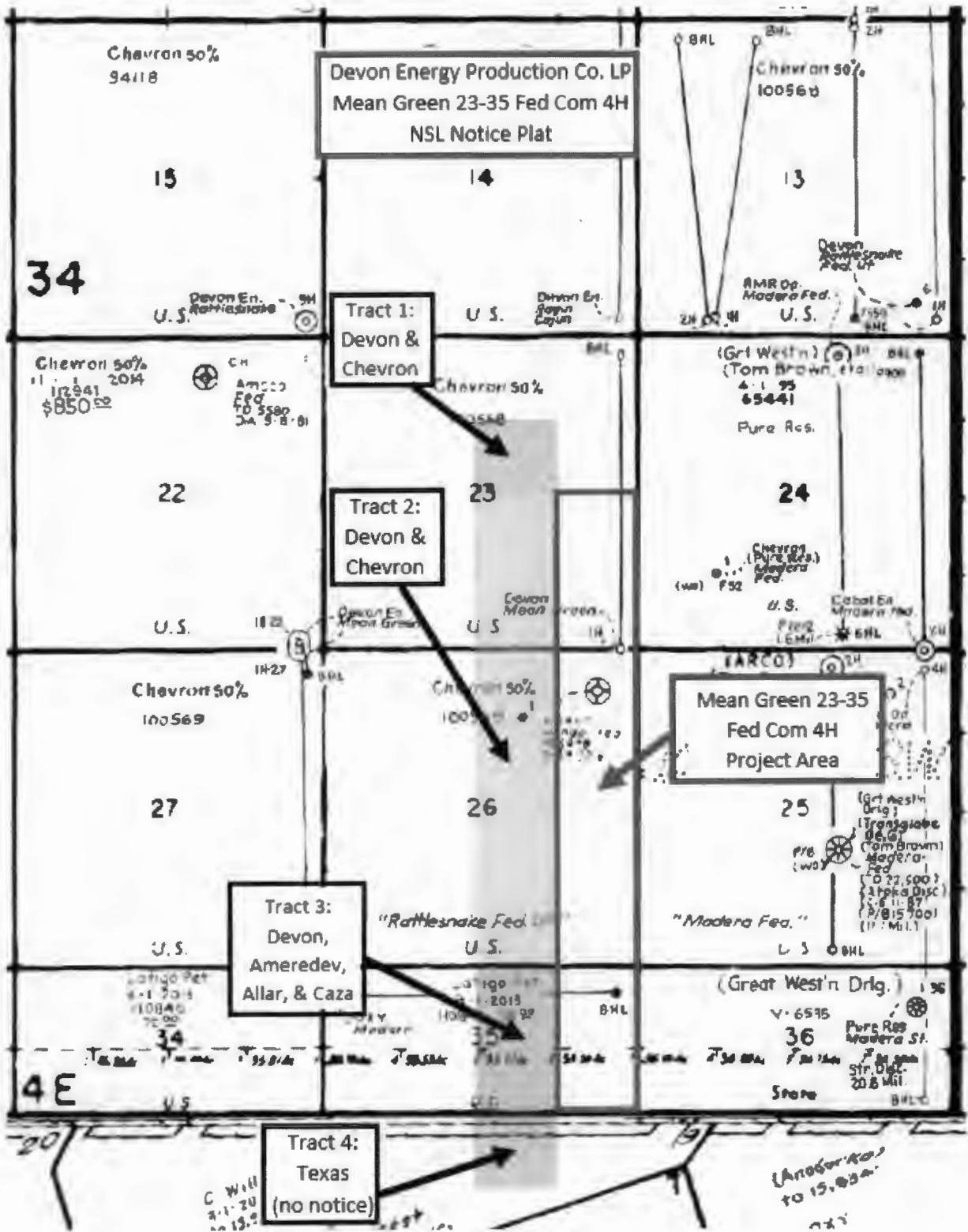
