Dear Ms. Wilson:

Reference is made to your request on behalf of Mesquite SWD, Inc. (the "operator") to extend the deadline stipulated in order SWD-1558 based upon the approval date of June 16, 2015, to commence injection for the above referenced well for an additional six months for reasons outlined in the attached correspondence. Prior to the required date to commence injection of the administrative order, the Division approved an extension of one year making the new date to commence injection June 26, 2018.

It is the Division's understanding from your request that there have been no significant changes in the information provided in the application submitted for review and approval of this order. The additional evaluation for the extension included a review for the completion of new wells within the Area of Review that penetrated the approved injection interval and any changes in ownership of affected persons notified for the original application.

The Division finds that granting this request to extend this administrative order is in the interest of conservation, will prevent waste, and will protect the environment.
