Pursuant to Finding Paragraph (9) of Order No. R-20414, Kaiser-Francis Oil Company applies for approval of an unorthodox oil well location for the following well:


The well will be drilled to a depth sufficient to test the Bone Spring formation (Bell Lake; Bone Spring, South Pool). Under Order No. R-14600 the pool is spaced on 480 acres with special well location rules. A Form C-102 is attached as **Exhibit A**.

The unorthodox location is requested to maximize the productive length of the wellbore.

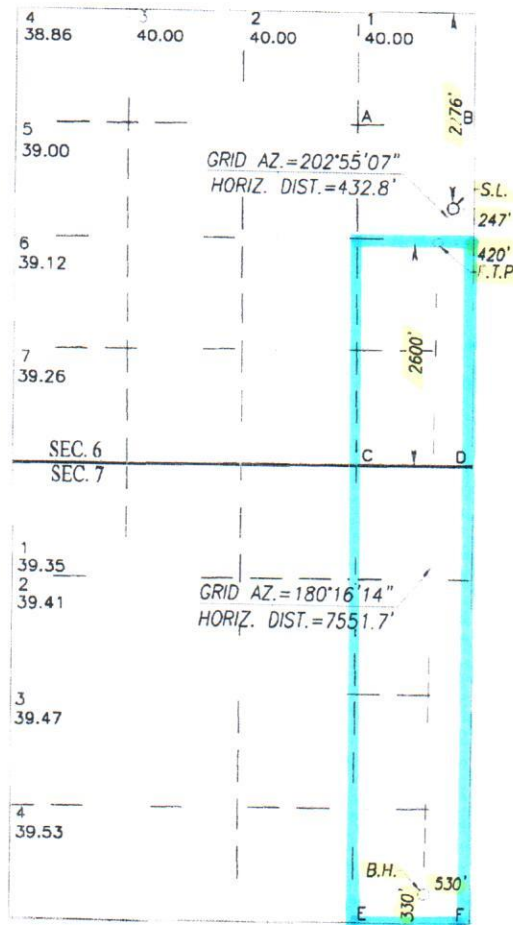

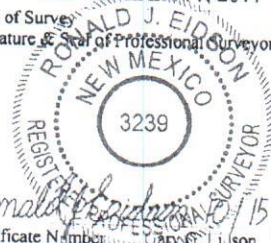
