Hilcorp Energy Company ("Hilcorp") requests approval of a non-standard horizontal spacing unit ("HSU) for the subject horizontal well pursuant to Paragraph (5) of Subsection B of 19.15.16.15 NMAC.

Paragraph (3) of Subsection B of 19.15.16.15 NMAC, states:

"The horizontal spacing unit shall comprise one or more contiguous tracts that the horizontal gas well's completed interval penetrates, each of which consists of a governmental quarter section or equivalent".

In these circumstances, dedicating a standard quarter section or equivalent to this well is not possible due to the segregating effect the federal unit boundary shared by the San Juan 32-7 Unit and Allison Unit has on Section 9, T32N, R7W. This can be seen on the enclosed map which references one of the equivalent quarter sections in the SW/4 of Section 9 bordered in pink.

Due to this, Hilcorp has formed the following non-standard HSU situated in Township 32 North, Range 7 West which can be seen on the attached map bordered in red:

- Lot 4, NW/4 SW/4, Lot 14 (collectively "W/2 W/2") of Section 9
- Lot 1, NE/4 SE/4, Lot 5 (collectively "E/2 E/2") of Section 8

• NW/4 of Section 16

Approval of this non-standard HSU is necessary to maximize recovery of oil and gas reserves and appropriately limits the acreage dedicated to this well to the Federal Unit in which it is located.

To support this request, the following has been attached:

- 1) Map identifying HSU in relation to Federal Units involved
- 2) List of affected persons




