Apache would like to request an Administrative Surface Commingling Order to include the following producing pools: Penrose Skelly; Grayburg (50350), Eunice; San Andres, SW (24180), Paddock (49210), Blinbry Oil & Gas (Oil – 6660), Tubb Oil & Gas (Oil – 60240), and Drinkard (19190). Wells with DHC Orders are noted on well list. Also included are two plugged wells, in case they were to ever be re-entered.

Enclosed please find forms C-102 and well test information for all wells on the lease. These wells are all marginal producers and production will be allocated monthly by well tests. Per the attached land letter, interest ownership between pools is identical and common throughout, 100% Apache.
