The commingled oil and gas production from the wells detailed above shall be measured and sold at the Culebra Bluff East 8 CTB Central Tank Battery (CTB), located in Unit F, of Section 8, Township 24 South, Range 29 East, NMPM, Eddy County.

Production from the subject wells shall be determined as follows:

CB SE 5 32 Federal Com Well No. 11H, and CB SE 5 32 Federal Com Well No. 12H, and CB SE 5 32 Federal Com Well No. 13H shall be measured at Train 1. CB SE 5 32 Federal Com 3 Well No. 1H. CB SE 5 32 Federal Com 3 Well No. 2H, and CB SE 5 32 Federal Com 3 Well No. 3H

shall be measured at Train 2. The oil and gas production from each of the diversely-owned Leases shall be measured with allocation meters at their respective trains prior to commingling.

The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

For future additions of wells, leases, and pools to this commingling operation, notice shall only be given to those interest owners in the wells, leases or pools to be added, in accordance with Division Rule 19.15.12.10 C (4) (g) NMAC.

Subsequent wells within Leases approved by this order may be added to this administrative surface commingle application with a Sundry notice to the Engineering Bureau.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

This approval is subject to like approval from Bureau of Land Management before commencing commingling operations.

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.
