Reference is made to your application received on September 25, 2019.

This vertical well was drilled at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by Hearing Order R-11067, which provides for 40-acre units, with wells to be located at least 330 from the QTR/QTR line and 660 feet from outer unit boundaries.

This well's completed interval is as close as 80 - 205 feet to the eastern edge and 330 feet to the southern edge of the spacing unit. Encroachments will impact the following tract.

Section 13, encroachment to the SW/4 SE/4
Section 24, encroachment to the NW/4 NW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches. However, the ownership is identical in the affected tract; therefore, notice is not required.

The Division understands you seek this unorthodox location due to surface issues of the well at its orthodox location and thereby to efficiently produce resources within the Glorieta-Yeso formation underlying the SW/4 of the SW/4 of Section 13.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13(B) NMAC, Division approves this unorthodox location.

The above approvals are subject to your following all other applicable Division rules.

Jurisdiction of this case is retained for the entry of further orders as Division deems necessary.
