Sorry for the delay in sending this.

We have improved our data format in our SWD permit applications, to be easier to read and interpret, so I have made some minor changes in this application to simplify administrative review. This involved changing data regarding affected persons from the AOR of 2 miles, to 1 mile; updating C108 section V and indexes to more accurately reflect information presented on plates and tables; presenting affected person (lessee/lessor and surface owner) information in a compiled Table 2 which is much easier to read. All affected persons in 1 mile AOR have been notified, the actual notifications were mailed to all in 2 mile radius so more than required were notified. No technical data has been revised with this submission.

I also wanted to let you know that XTO advised us that they were protesting this SWD. To my knowledge, we did not receive any information from NMOCD regarding this protest, and you may not have a record of this protest.

Please let me know that you received, I did reduce file size.
