Gentlemen:

I had spoke w/ Dylan about this a couple of months ago and at the time, submitted an updated WBD w/ 7.0" tbg, etc.

I asked if I should do this routinely for C-108s we currently had in and had NOT been to hearing – meaning those were the ones with the original 5.5" tubing configurations illustrated.

I think, these are the only 2 remaining that would need these revised WBDs to go with the current C-108s. (WLC South SWD #1 and SEC SE SWD #3 – Note: the WBD for the WLC-S#1 is a different design – currently working on the BLM APD for this one so I've included that new format.)

The intent would be for ALL Trove SWD prospects to be spec'd with the 7.0" tubing.

If you happen to be processing a C-108 without a revised WBD to show the 7.0" tubing, please let me know and I'll get that in ASAP.

This effort on both our parts would alleviate the need to revisit an approved permit to get an amendment.
