

To Whom It May Concern,

Overflow Energy is currently in the process of receiving the commission's approval of the form C-105 for the Rose SWD # 1 and its companioned sundry notices. We spudded the well back on September 22, 2019 and moved the completion rig in directly after drilling was completed. Several issues have arisen on sundry notices and the completion report that Overflow must resolve to remain in compliance. We respectively request for a hundred-eighty (180) day extension of Order SWD-1785 to resolve the issues. We understand that we may not inject into the Rose until we have received NMOCD approval.

9/19/2019	John Prejean (OE representative) discussed changing the permit casing design to match updated geology prognosis with Mike Batcher (District Supervisor). He asked that OE run these changes by Ray Padany (District Geologist) and then transferred John over to Ray. After discussing the discrepancies with the permit depth of the Salado and concern with not pushing our 1st intermediate string into the Delaware Series Sands, Ray gave his verbal approval to make the discussed changes and asked that a formal sundry be submitted to the district office by mail, as they could not accept emailed sundries at that time. The C-103 with the casing design changes was sent to Elizabeth Valenzuela (OE representative), by email, to be signed and mailed, per Ray's instructions.	Yes
9/22/2019	Rose SWD #1 was SPUD at 14:30	No
9/23/2019	Elizabeth mailed off the casing design C-103 to the District II office.	Yes
9/25/2019	Elizabeth mailed off the Surface Casing C-103 to the District II office.	Yes

10/1/2019	Elizabeth mailed off the Intermediate Casing C-103 to the District II office.	Yes
10/8/2019	Overflow Energy received call from the OCD District II concerning the changes to the surface and intermediate depths. Gilbert Cordero followed up with an email stating that we need to send them to Phillip Geotze.	Yes
10/8/2019	Elizabeth notifies John that the State of NM has issues with our surface and intermediate casing depths	Yes
10/9/2019	John had a phone conversation with Gilbert Cordero about the issues with the Casing Design Sundry. He informed John that the District Office should not have given us a verbal approval, as all SWD changes must go through Phillip Goetze. Gilbert shared Phillip's phone number and John called him directly to determine how to address their issues. Over the phone, Phillip explained that he would have to approve the changes - not the District Office. He asked that John send him all of the reports and logs that would help him make a decision on this matter.	Yes
10/9/2019	John emailed Phillip the Casing Design Change Sundry, Mud Log of the surface hole and a recap of the surface & intermediate casing & cementing reports.	Yes
10/15/2019	Due to not getting a response from the email on 10/9 and we were preparing to set our 2nd intermediate casing string, John called Phillip to confirm we had his approval to move forward with operations. He expressed disappointment that we didn't follow the proper procedures to file the change and that we could continue and expected us to follow proper procedures in the future. John followed up the call with an email to Phillip. This was the last communication that John had with Phillip.	Yes
