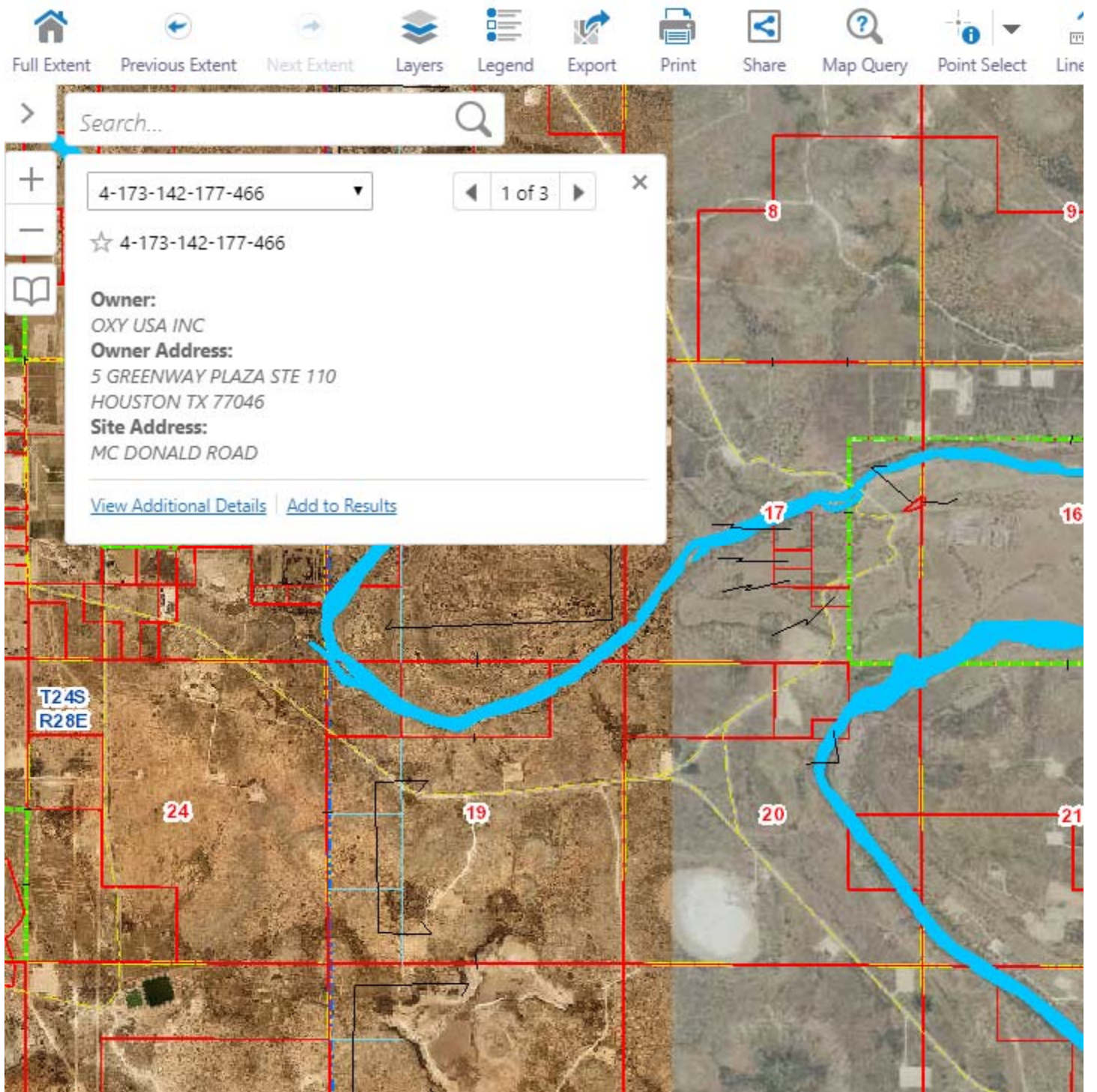

It would appear that you may have just squeaked in before the deadline for extension. However, your request is lacking some of the additional information that we require in order to facilitate.

- We will need proof that there are no new affected parties in the AOR since the issuance of the original order
- Proof that there are no new wells in the AOR whether they penetrate the injection interval or not
- Proof of notice to any new affected parties (including the new surface owner) per 19.15.26.8(B) NMAC

If you can provide these pieces of information then we can move forward with consideration of the extension.
