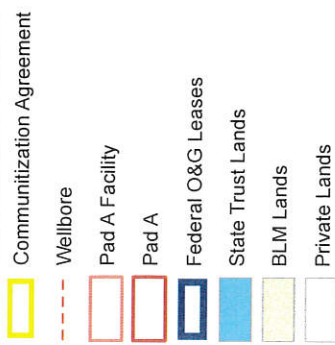

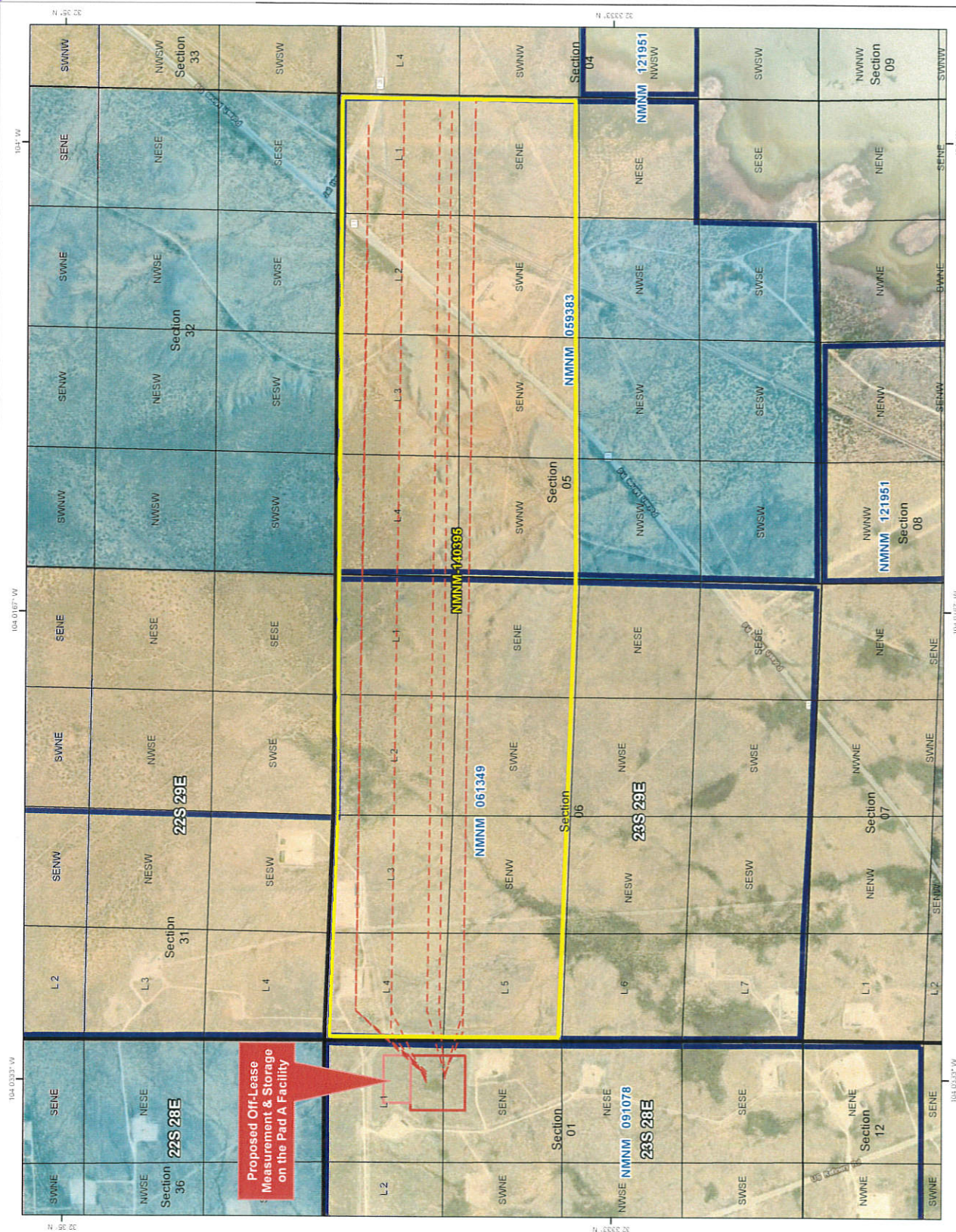

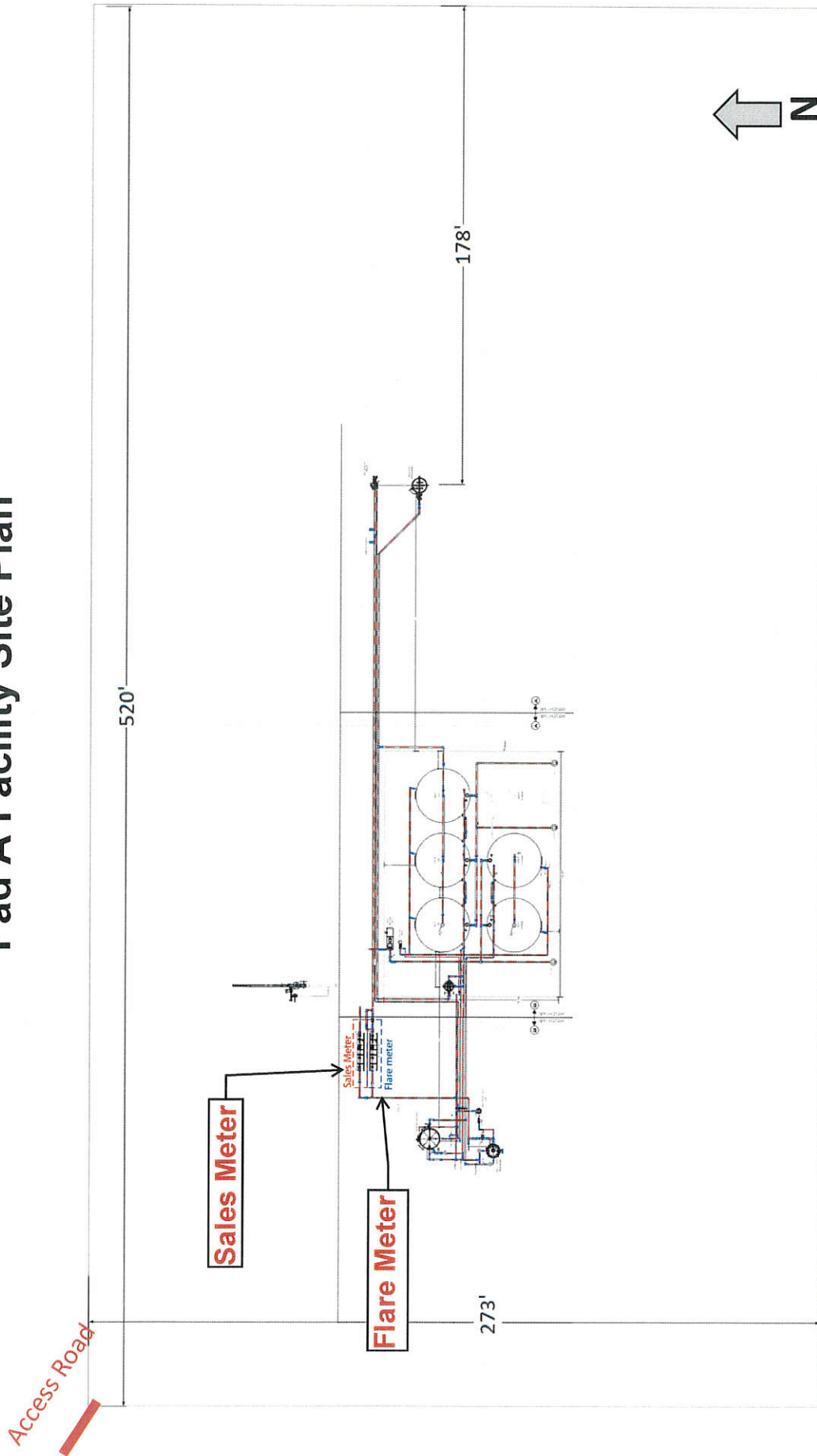
NAD 1983 New Mexico State Plane East
