Hello Cory,

An application can be submitted to amend an order to add additional wells. However, if a lease or pool is being added, the interest owners in that lease or pool will need to be notified regardless of if they had been notified in the original application. As such, infill wells are likely to be the only ones that will be able to be added without re notification. Typically, this will also require that the original application specifically states that new wells may be added with only notification to the interest owners in new production added. Having said that, I would say that if you are including the specific wells to be added in the original notification as done here, you can add those wells later because you had stated you are wishing to commingle those wells as well.

Is the intention to commingle the production from these wells? If so, these applications will need to be corrected to reflect pool/lease commingling and off-lease measurement and then re-noticed. If the intention is to not commingle the production from these wells and instead only off-lease measure, the applications will need to be split up into multiple off-lease measure applications so there is one for each pool within each lease. Note, that to keep the production isolated will mean that all vessels, tanks, lact units, etc. for each pool within each lease will need to be completely isolated from any vessel, tank, lact unit, etc. for any other pool or lease.
