Re: Application of Devon Energy Production, LP, for administrative approval of an unorthodox well location for its Thoroughbred 10-3 Fed Com #734H Well in the E/2 of Sections 3 and 10, Township 26 South, Range 31 East, N.M.P.M., Eddy County, New Mexico.

Dear Ms. Sandoval:

Devon Energy Production, LP (“Devon”) (OGRID No. 6137) requests that this application replace the original application filed on July 8, 2020. In this application, Devon seeks administrative approval of an unorthodox well location for its **Thoroughbred 10-3 Fed Com #734H Well** (API No. 30-015-46907) to be completed within the Purple Sage Wolfcamp Pool (98220) underlying the E/2 of Sections 3 and 10, Township 26 South, Range 31 East, N.M.P.M., Eddy County, New Mexico.

This well will be drilled from a surface location 200 feet from the south line and 1380 feet from the east line (Unit O) of Section 10 to a bottom hole location 20 feet from the north line and 330 feet from the east line (Unit A) of Section 3. The first take point will be located 330 feet from the south line and 330 feet from the east line (Unit O) of Section 10, and the last take point will be 100 feet from the north line and 330 feet from the east line (Unit A) of Section 3.

Pursuant to Division Order R-14262, this acreage is governed by the Special Rules for the Purple Sage-Wolfcamp Gas Pool which provide for wells in the Wolfcamp formation in Eddy County to be located no closer than 330 feet to the outer boundary of the spacing unit. The completed interval for the **Thoroughbred 10-3 Fed Com #734H Well** will be unorthodox because it is closer than 330 feet to the northern boundary of the spacing unit in Section 3. Approval of the unorthodox completed interval will allow Devon to use its preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Thoroughbred 10-3 Fed Com #734H Well** encroaches on the drilling and spacing unit to the north in Section 34, Township 25 South, Range 31 East.

Exhibit B is a land plat for Sections 3 and 10 that shows the proposed **Thoroughbred 10-3 Fed Com #734H Well** in relation to the adjoining spacing unit to the north in Section 34, Township 25 South, Range 31 East.

Ownership is diverse between the subject spacing unit and the spacing unit to the north. **Exhibit C** reflects that a copy of this application with all attachments has been sent by certified mail to each affected person advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application.

Exhibit D is a statement from a Devon's petroleum engineer confirming that Devon's requested unorthodox location is necessary to optimize well spacing, thereby preventing waste.









It is Devon's responsibility as a prudent operator to maximize lateral length and to minimize reserves left in the ground.
