Dear Mr. McClure:

FAE II Operating LLC, OGRID: 329326, requests administrative approval for surface commingling and off-lease marketing of gas production from the Eumont Gas Pool for its Turner State #4 well located in Section 32 of Township 20S, Range 37E as shown on the map in Exhibit A. The existing Turner State Compression System is comprised of the A B Reeves #7 and Turner State #3 wells, which are located on two separated leases. The two separate leases are also identified by outline and legend. Exhibit B offers further detail on the relevant leases and wells.

The attached battery diagrams, Exhibits C and D, are accurate schematics of the current facility and the proposed commingled facility, respectively. A new gas flowline will be laid from the Turner State #4 well to the Turner State #3 and tied in to the Turner State Compression System. The Turner State #4 will have a gas orifice allocation meter manufactured and assembled in accordance with American Gas Association specifications.

After a review of internal records, the interest owners are not identical for the wells mentioned above. As such, we have notified all relevant parties of our intent to commingle production (see attached letter). The working, royalty, and overriding royalty interest owners as shown in Exhibit E have been notified of this application by certified mail. Copies of the certified mail receipts are attached as Exhibit F.

This proposed commingling of production is in the interest of conservation and will not result in reduced royalty or improper measurement of production. Exhibit A – Lease Boundaries Map

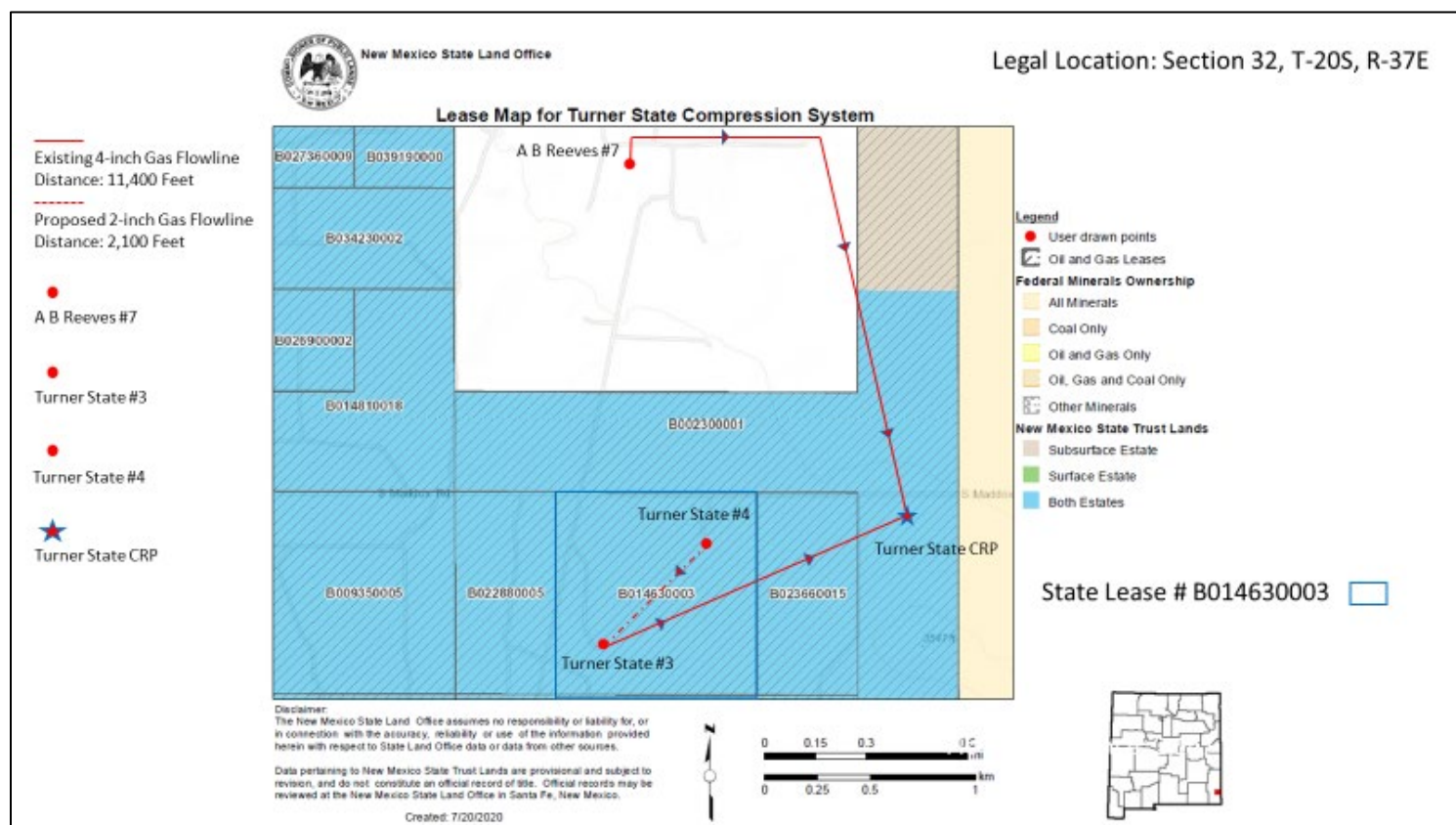
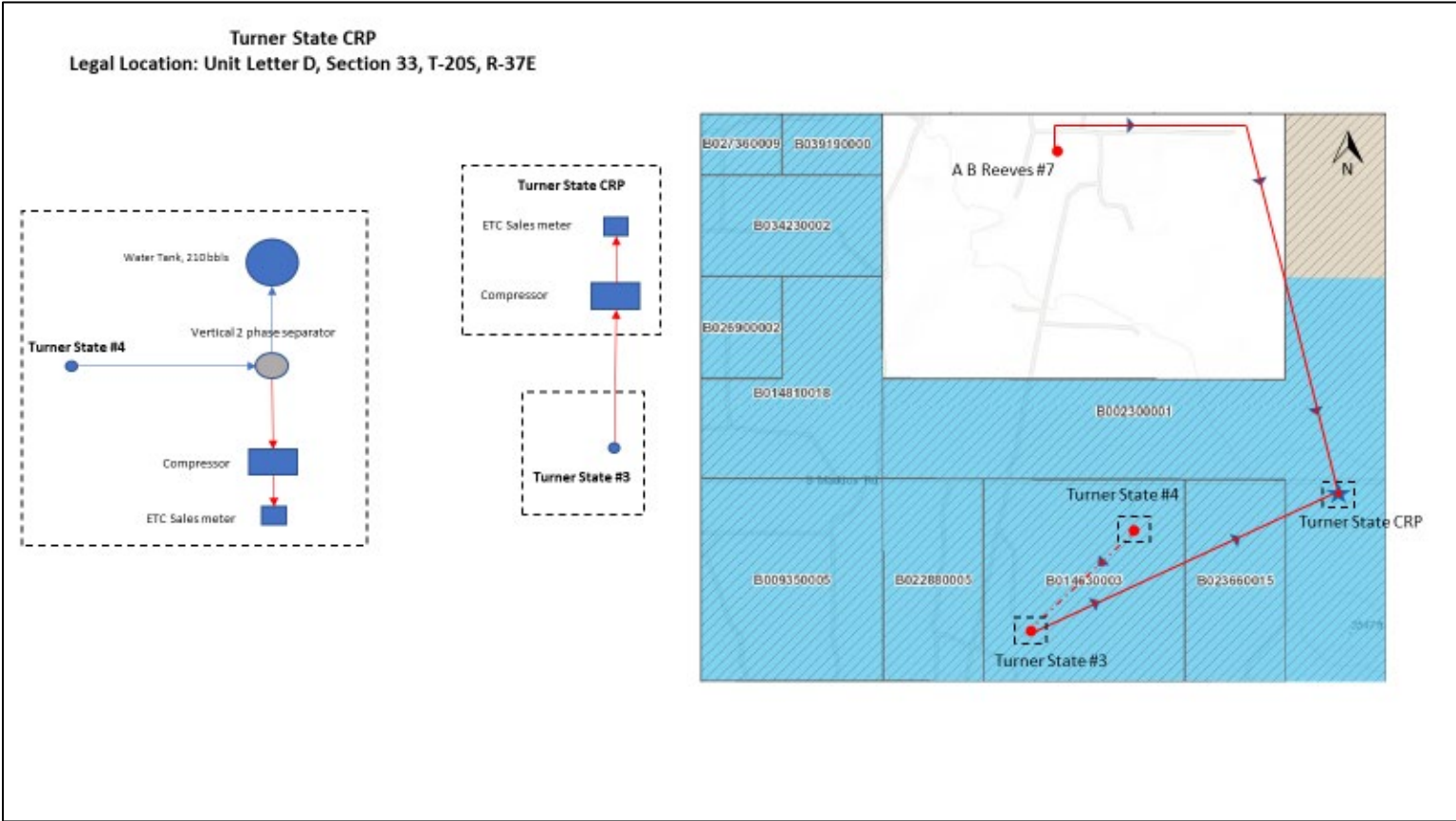

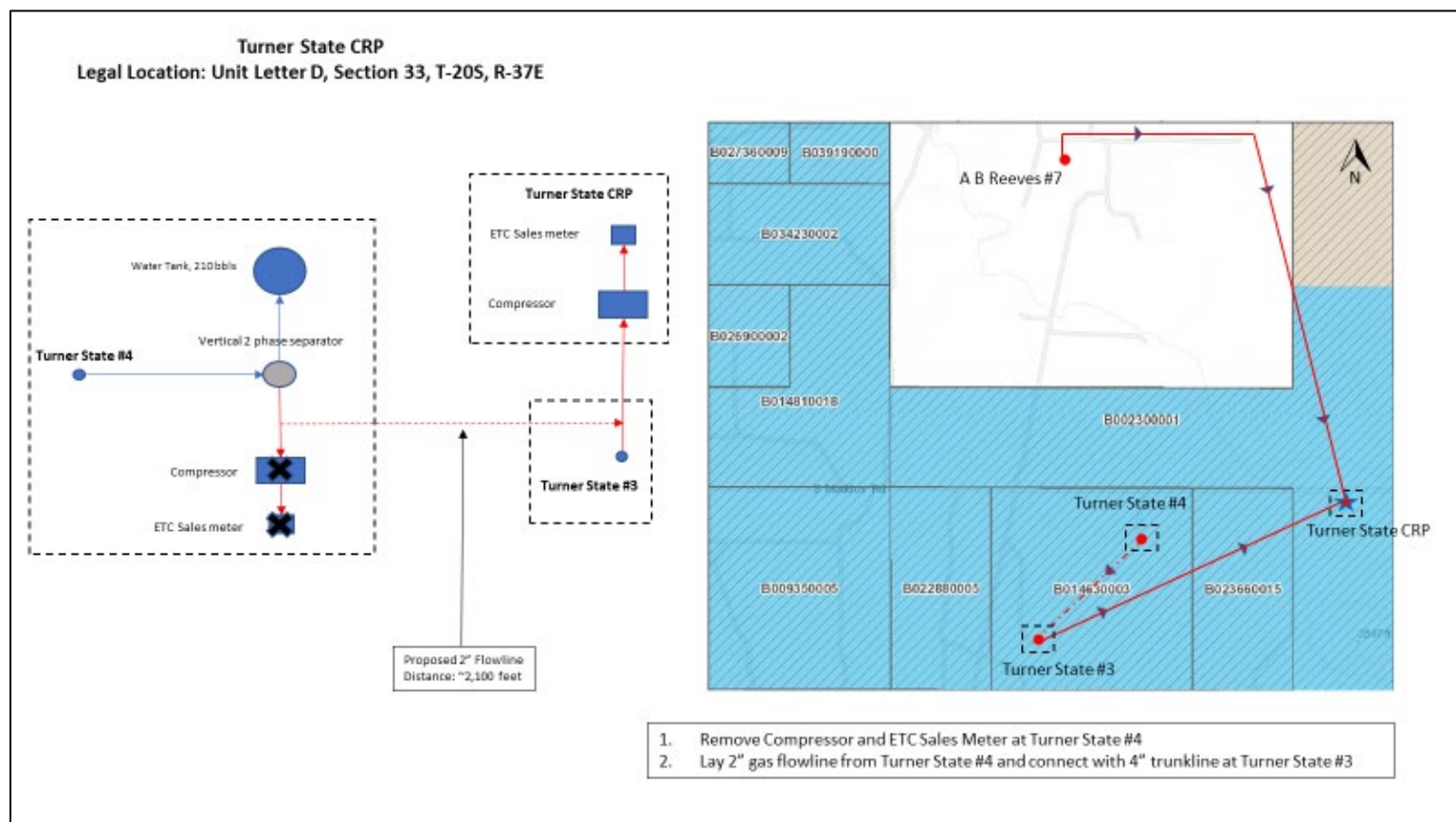
