Chevron U.S.A., Inc. ("Chevron") is hereby authorized to surface commingle production from the following Pools:

North Monument Abo (46980)
Northeast Monument Drinkard (97008)
North Monument Delaware (97750)
Monument Yeso (20070)

and from the diversely owned wells, located on State of New Mexico oil and gas leases in Lea County, New Mexico, identified on Exhibit A attached hereto. We understand that ownership is identical as to all interests in the wells included within each ownership group, as listed on Exhibit A. However, ownership is not identical as between ownership groups. We further understand that each well produces from only one pool, as identified on Exhibit A, and that there is no downhole commingling in any of these wells.

Oil and gas production will be commingled at the Monument 12/13 Battery, located in the North half of the Southwest Quarter of Section 12, Township 19 South, Range 36 East. Production from the wells identified in Exhibit A is hereby approved for off lease measurement and sales.

Production from each ownership group, as shown on Exhibit A, shall be measured continuously with calibrated allocation meters prior to commingling with production from any other ownership group. The allocation meters shall be calibrated in accordance with Rule 12.10.C(2) [19.15.12.10.C(2) NMAC]. Production shall be allocated among wells within each ownership group by the well test method.




This approval is subject to like approval by the Commissioner of Public Lands of the State of New Mexico before commencement of commingling operations.
