Mr. McClure,

Matador has advised that all of these wells are within the Northeast Kemnitz State Unit that comprises roughly 5,280 acres of entirely state acreage.

There is no comm agreement for the Northeast Kemnitz 22 State 12 because that well falls entirely within one state lease and will be part of the Northeast Kemnitz State Unit, pending approval by the State Land Office.

The Northeast Kemnitz 233H will not have a comm agreement because it will be part of the Unit, pending the same economic determination approval by the SLO.

Likewise, the Northeast Kemnitz Unit 13 is, or will be, part of the State Unit, pending the economic determination approval by the SLO, and the spacing is entirely on the referenced lease.
