COG Operating LLC requests administrative approval of a non-standard location for the Myox 30 State Com 706H, API number 30-015-47095. The 706H well is proposed to be completed in the Purple Sage; Wolfcamp pool, Pool Code 98220. This pool has special pool rules specifying the completed interval must be located 330 feet from the exterior boundary of the applicable spacing unit.

Approval of the non-standard completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

The proposed completed interval is projected as follows:

Surface Location –	380' FSL & 1296' FWL UL M Sec. 18-25S-28E Eddy County, NM
First Take Point –	10' FNL & 450' FWL UL D Sec. 19-25S-28E
Last Take Point –	100' FSL & 450' FWL UL M Sec. 31-25S-28E
Bottom Hole –	50' FSL & 450' FWL UL M Sec. 31-25S-28E
Proposed Pool–	Purple Sage; Wolfcamp (Pool Code 98220)

This will be a horizontal oil completion.

The Horizontal Spacing Unit will be 960 acres, W/2 of Sec 19, W/2 of Sec 30, W/2 of Sec. 31-25S-28E as shown on the enclosed C-102. **The HSU defining well is the Myox 30 State Com 705H.**

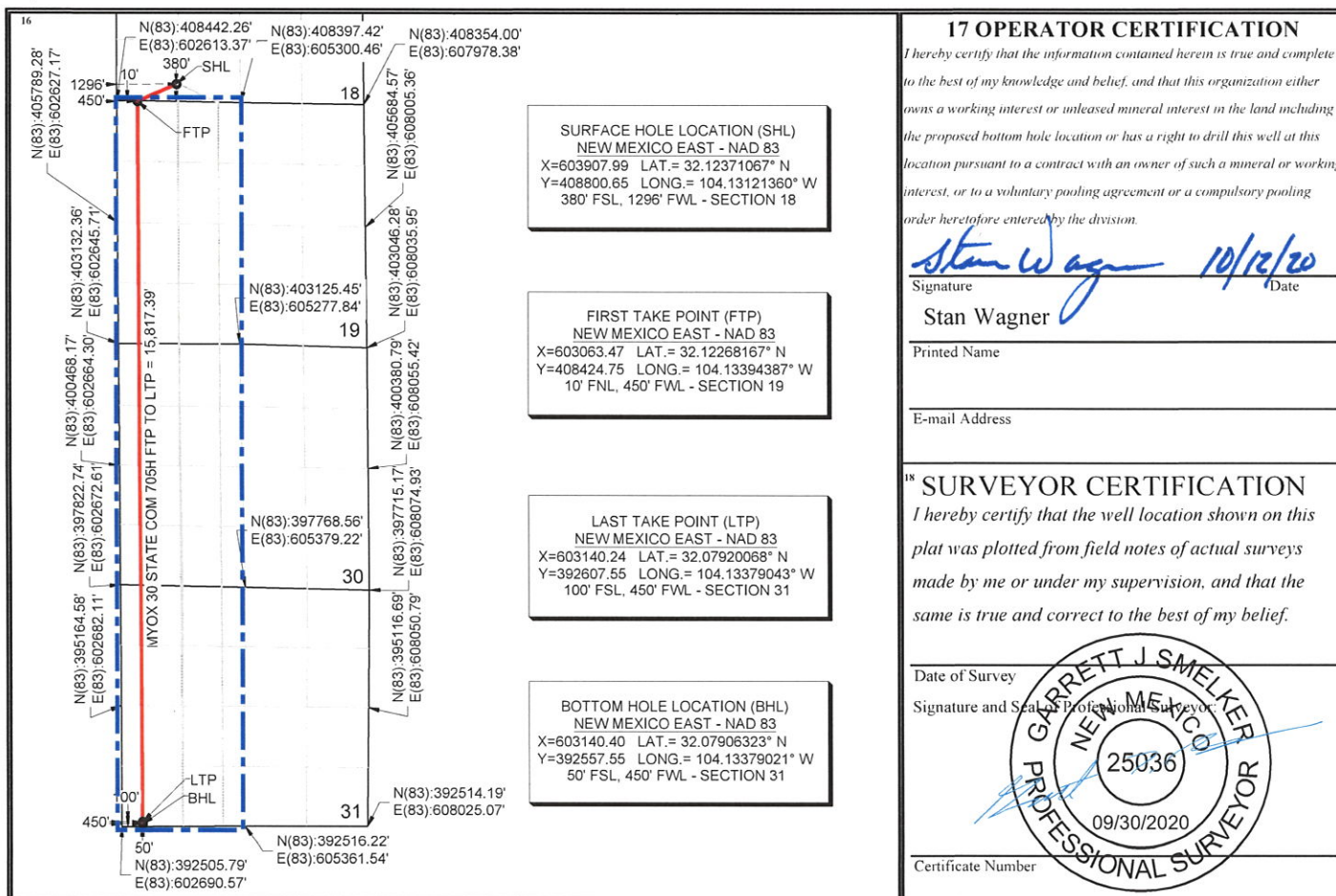

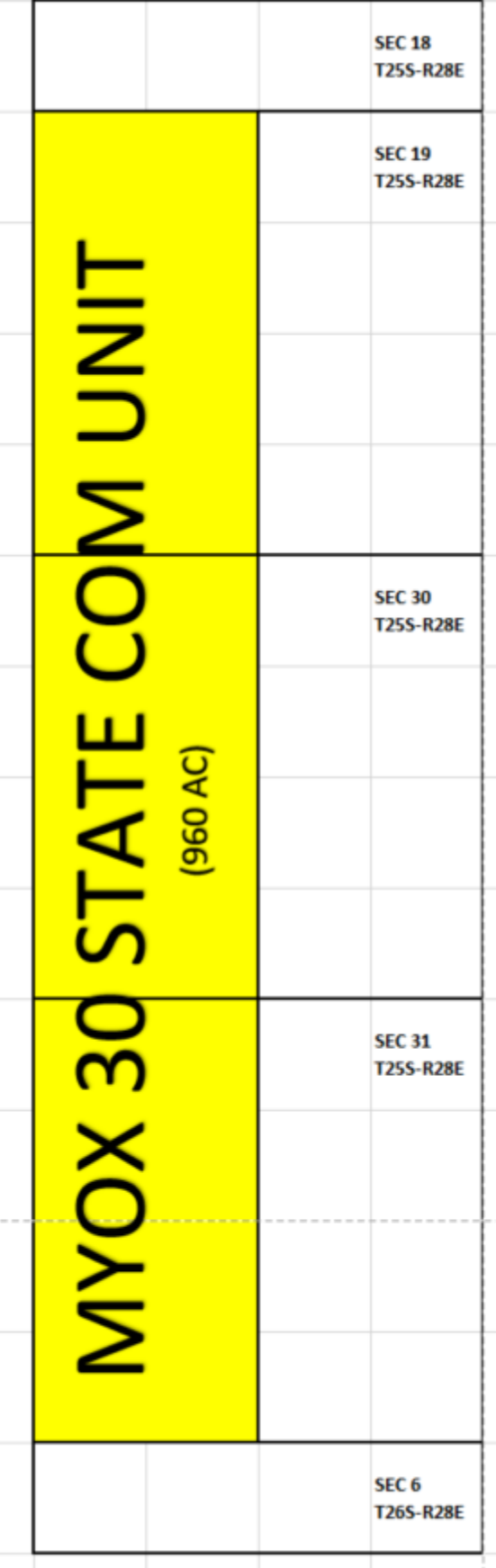
