However, the ownership is identical in the affected tracts therefore, notice is not required.

Division understands you are seeking this unorthodox location due to drilling too close to the unit boundary within the Wolfcamp formation underlying the W/2 E/2 of Section 19 and the W/2 NE/4 of Section 30. Therefore, maximize resource recovery and preventing waste.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.
