### Good morning,

Recently, I've been trying to update information regarding 3 of Ray Westall's extension requests that have become quite old. The DHY A and DHY B were done and you guys acknowledged that those are back in progress.

This one is regarding the Saguaro SWD and the AOR review revealed that the lease for the surface location had changed to WPX. Subsequent to that acquisition, WPX merged (to include this lease) with Devon. I began communicating w/ WPX on March 23<sup>rd</sup>. My initial contact, Lorri Kline got me in touch with Tanner Tepe. Several emails were exchanged in the process with the last contact from Tanner on April 19<sup>th</sup> – to which I replied on April 23<sup>rd</sup>. As of today, I haven't heard back however; I believe OCD's mandate for notification has been fulfilled. I would note that all the operators have been notified including Mewbourne which gave its consent to the extension a few weeks prior to this email.

I've attached a document that effectively captures the exchange between myself and WPX/ Devon. As they are the lessee and have now been aware of this permit extension request for several weeks, I would request that the extension be granted as soon as possible. (I excerpted several pages that were voluminous redundancies!! Still, I believe it fully discloses my attempts to get WPX/ Devon consent.)

Ray Westall Operating is waiting for OCD approval so that we may then notify the State Land Office so that the applicable SWD easements may also be issued.

Please let me know if you have other questions OR that you are in receipt of all that is needed for processing to continue.



In NM, within one-half mile radius of a proposed SWD, an applicant is required to notify the 1) surface owner, 2) operator of record and 3) the lessee in the absence of an operator.

So, technically, we're probably covered. This one is a little odd as the permit had already been issued in 2017. All my client was doing was requesting an extension for the expiration date back in 2018. That request was made however; NM got a little crazy for a while with the huge influx of SWD applications, state gov administration changing and new and changing personnel at the Oil Conservation Division. Through all that, OCD apparently misplaced the request (I furnished proof to them) AND, it was taking them 2 years or more to get new permits out. Anyway, I inquired recently about the status of the original request and that's how we got here – trying to get a ONE year extension on a permit that technically expired over 2 years ago! OCD accepted that it was their administrative process that bogged down and asked me to conduct a new review of the 'Area-of-Review', AOR. I did that and saw that WPX acquired the subject lease some time during those years.

Mewbourne has already given me their consent so I'm probably covered. **But, since I've pulled you in and taken this much of your time (!)** it would probably help expedite my client's extension if you quickly emailed your consent to OCD OR, that you have been notified of the project and extension request and do not have an issue with it – or something to that effect. 


