Hello Jenny,

Unfortunately, Devon did not include within their notice to the interest owners that they wished to seek approval to do as you propose. As such, an application to amend the order will be required to add additional wells.

Upon that application you may wish to request approval to add new leases and pools and/or new wells producing from the authorized leases and pools. If so, it is also ideal to include that within the cover sheet sent to the interest owners.

The precise wording is not important, although many operators choose to word it along the lines of "Applicant requests to surface commingle the current and future wells producing from the following pools and leases..." Please note, you will also need to list the current wells. Upon granting approval of this request, you could then add new wells producing from the same leases and pools via sundry without notice.

If you wish to request approval to only notice the interest owners of new leases and pools to be added via amendment, then you will need to also make that request and reference rule 19.15.12.10(C)(4)(g) NMAC. These two approvals are separate and can be sought together or separately.
