The New Mexico State Land Office (SLO) protests the SWD application of NGL Water Solutions, LLC for the proposed salt water disposal well, Minuteman SWD #1, located 659' FSL & 592' FWL, Sec. 14-24S-33E.

SLO protests the intended location of this SWD due to its proximity to state trust lands. This well is within 1/8 mile, or 592' of state trust land (15-24S-33E). The State Land Office may determine that there are additional grounds for objection. Please let me know if you have any questions or need additional information.
