Dear Ms. Bennett:

The Oil Conservation Division ("OCD") has reviewed your September 30, 2021 request to extend the deadline in the referenced order to commence injection into referenced well. The request, which was received prior to the deadline, states the reasons for granting an extension, that no additional wells penetrating the approved injection interval have been drilled within the Area of Review since the referenced order was granted, and that additional affected parties in the AOR, if any, were notified of your extension request and did not protest the extension. Accordingly, OCD reviews your request administratively.

On December 18, 2020, OCD adopted a new form of order granting injection authority for UIC wells to ensure the prevention of waste and the protection of correlative rights, public health, and the environment as required by the Oil and Gas Act and OCD's delegation of authority from the U.S. Environmental Protection Agency. A copy of the new form of order is attached for your review. OCD will issue this form of order for any new applications to inject and requests to extend the deadline to commence injection under existing orders. Please advise whether you concur in the granting of injection authority using the new form of order as set forth below.

Hello,

Attached please find a written request submitted on behalf of Permian Oilfield Partners, LLC (Permian) requesting an extension of time to commence injection under Order R-21196 in the Ramrod Fee SWD #1. As you will see from the attached request, Permian's plans to develop this injection well have been delayed for a number of reasons, including among other things COVID and the State Land Office's de novo hearing for this order. The SLO's de novo case has now been dismissed and the SLO has filed with the Division a withdrawal of its objections to this well. You will also see that Permian is willing to either incorporate language from the new UIC form of permit or even have its current order replaced by the new form of UIC order, as part of its extension request. As you will see from the attached, the SLO, also cc'd on this email, concurs in Permian's extension request.

I will be submitting similar extension requests for three other Permian SWD orders that were also subject to de novo hearing applications, and which de novo cases have also been dismissed and the SLO's objections withdrawn.
