Reference is made to your application received on March 11<sup>th</sup>, 2022.

This vertical well was recompleted into an unorthodox location described above in the referenced pool and formation. Special pool rule R-565-C governs this well, which provides for 160-acre spacing units with setbacks no closer than 790 feet from the outer boundary of the spacing unit.

This well's completed interval is as close as 375 feet to the southern edge of the spacing unit. Encroachment will impact the following tracts.

Section 19, encroachment to the SW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are requesting this unorthodox location due to recompleting this well in another formation thus preventing of waste of resources and the protection of correlative rights within the Pictured Cliffs formation underlying the NW/4 of section 19.
