STIPULATED FINAL ORDER

Pursuant to the New Mexico Oil and Gas Act ("Act"), NMSA 1978, Section 70-2-1, *et seq.*, and 19.15.5.10(C) NMAC, the Director of the Oil Conservation Division ("OCD") and Extex Operating Company, OGRID #330423 ("Extex") enter into this Stipulated Final Order ("Order") to resolve the above-referenced matter.

1. OCD is charged with the administration and enforcement of the Act and the implementing rules and has jurisdiction to regulate Extex's wells in the state of New Mexico.

2. Extex is the operator of record for the wells identified in Exhibit A.

3. On May 19, 2022, OCD issued a Notice of Violation ("NOV") to Extex alleging Extex exceeded the number of inactive wells allowed by 19.15.5.9(A)(4)(b).

4. OCD subsequently identified additional inactive wells, which Extex agreed to address as part of this Order.

5. On June 3, 2022, Extex requested informal resolution of the NOV.

6. Extex admitted the alleged violations.

7. To resolve the alleged violations, Extex agrees that:

(a) No later than the specified date, unless extended upon request of Extex for good cause shown, Extex shall return to production each well identified in the column "Return to Production By" in Exhibit A and give OCD written notice by electronic mail.

(b) No later than the specified date, unless extended upon request of Extex for good cause shown, Extex shall submit to OCD Permitting an approvable C-103Q for each well

identified in the column "P&A and Release By" in Exhibit A, and give OCD written notice by electronic mail.

8. Written notice required by paragraph 9 shall be given to OCD at the following electronic mail address: Rob.Jackson@state.nm.us.

9. If Extex complies with this Stipulated Final Order, OCD shall abate all of the civil penalties.

10. If Extex fails to complete an action specified in paragraph 7, then Extex shall pay a stipulated penalty of \$100.00 for each day until it completes the action.

11. If Extex fails to pay the stipulated penalty or portion thereof no later than 30 days after service of OCD's written demand, it shall pay interest on the stipulated penalty or unpaid portion thereof until paid in full at the interest rate of 8.75 percent as provided in NMSA 1978, § 56-8-4(A).

12. OCD reserves the right to revoke the authorization to transport and require a well to be plugged and abandoned if Extex fails to complete an action specified in paragraph 8 more than 90 days after the specified date in Exhibit A or, after the date as extended by OCD for good cause shown.

13. Extex admits OCD's jurisdiction to file the NOV, consent to the relief specified herein, and waive the right of review by the Oil Conservation Commission.

14. The persons executing this Order represent that they have the requisite authority to bind their respective parties and such representation shall be legally sufficient evidence of their actual or apparent authority.
