Re: Objection to the Application for Administrative Approval of Non-Standard Location for Spur Energy Partner LLC's Ross Ranch 22 10H (API pending) – N. seven Rivers; Glorieta-Yeso (Pool Code 97565).

Mr. Lowe:

Our firm represents Trabajo del Spear, LP, in connection with the above-captioned Application for Administrative Approval of Non-Standard Location (the "Application") filed by Spur Energy Partners LLC ("Spur"). Trabajo del Spear, LP is an Affected Party as the owner of an undivided mineral interest in an Affected Tract as identified in Spur's Application and as those terms are defined by the New Mexico Administrative Code.

As allowed by the 19.15.15.13(D) NMAC, Trabajo del Spear, LP ("Trabajo") hereby files its written objection to the administrative approval of the Application and requests that the director set the application for a hearing as allowed by 19.15.15.13(E) NMAC. Trabajo needs additional time to review the well proposal information including all geotechnical data, proposed fracking pattern, drainage projections, and seismic and other relevant reservoir information in order to determine how Trabajo's rights will be affected, whether the proposed well will drain Trabajo's oil and gas, and what actions by the division may be necessary to offset the advantage of the unorthodox location as allowed by 19.15.15.13(F) NMAC.


