Reference is made to your application received on October 6th, 2022.

You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. 19.15.16.15(B)(3)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal well a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter-quarter section or equivalent.

This well's completed interval is as close as 60 feet to the eastern edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 13, encroachment to the W/2 E/2
Section 12, encroachment to the W/2 E/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location to allow for efficient spacing of horizontal wells in the Wolfcamp formation underlying the W/2 of Section 13 and the W/2 of Section 12. Thereby preventing waste within the location.


