Reference is made to your application received on November 18th, 2022.

You have requested to complete this horizontal well as a gas well described above in the referenced pool or formation. This well is governed by special rules, R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and provides for 320-acre units, with wells located at least 330 feet from a unit outer boundary.

This well's completed interval is as close as 100 feet to the northern edge and 100 feet to the southern edge of the horizontal spacing unit. Encroachment will impact the following tract.

Section 2, encroachment to the W/2 Section 23, encroachment to the W/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location to increase the potential completed horizontal lateral of the well and to minimize reserves left in the ground. Thereby preventing waste within the Wolfcamp formation underlying section 11 and section 14.

Per Subsection B of 19.15.15.13 NMAC, Division approves this unorthodox location.
