RE: **NMOCD-ACO-2020-009** 2023 Final Update

Dear Mr. Jackson,

Pursuant to the conditions of NMOCD-ACO-2020-009 ("Order"), EOG Resources, Inc. ("EOG") is required to submit a report no later than twelve months, twenty-four months, and thirty-six months after the date of issuance of the Order. The report states whether the wells have been restored to production, placed on approved temporary abandonment status, or plugged. Additionally, EOG is required to conduct a Bradenhead test on each well no later than twelve months, twenty-four months, or thirty-six months after the date of issuance of this Order and is also required to submit a compliance report for each test not later than thirty days after the date of that test.

This is the third and final report pursuant to the Order. EOG has removed all wells covered under the terms of the Order by either restoring them to production or plugging and abandoning them. Some wells have been transferred to other operators. At the time the Order was approved, it included 1889 wells. Since EOG's last report in April of 2022, the remaining 17 wells covered by the Order have been removed from the list. The attached Exhibit illustrates the status of each well.

Please let me know if you have any questions about anything contained in this correspondence and thank you, in advance, for your time. With the approval of the Oil Conservation Division, EOG will consider this Order expired.
