The proposal for remediation of the above referenced produced fluid release, submitted to NMOCD by Talon, LPE on behalf of Devon Energy Production Company, is approved with the following conditions/stipulations:

- \* Notify OCD District 2 office 48 hours prior to commencement of remedial activities.
- \* Notify OCD District 2 office 48 hours prior to obtaining samples where the analyses will be submitted to OCD.
- \* Submit a Form C-141 Final Report and closure report to OCD upon satisfactory completion of project.
- \* Project is to be completed and closure documentation submitted not later than October 8, 2011.
- \* Like approval by any other regulatory authority as may be applicable.

Be advised OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.

Devon Energy Production (Devon) is also advised that NMOCD has specific reporting requirements for produced fluid releases, regardless of surface or mineral ownership. Devon's notification to any other regulatory authority does not relieve Devon of responsibility for reporting to NMOCD. See (OCD Rule) 19.15.29 [New Mexico Administrative Code]
