Cimarex proposes perf and acidize the Cisco 10079-10295. Perf and acidize the Wolfcamp 9361-9650. Allocation percentages for each zone will be based on production log and furnished after production and cleanup.

It is anticipated that the reservoir pressure from these two shale zones will be compatible and the resulting volumes would not warrant a casing/tubing dual completion.


