Greetings,

NMOCD is in receipt of your document, "Soil Assessment and Remediation Work Plan", dated June 27, 2011, proposing methods for remediation of a produced fluid release, as referenced above. The remediation proposal is approved with the following stipulations and/or conditions of approval:

- Notify OCD District 2 office 48 hours prior to commencement of remedial activities.
- Notify OCD District 2 office 48 hours prior to obtaining samples where the analyses are to be submitted to OCD.
- Notify OCD District 2 office 48 hours prior to installation of any liner and/or cap.
- The area of sample points "S-3" and "S-4" will require further vertical delineation. Removal of additional material, including the proposed 2' and 4', respectively, may be required. Liner installation in the area of "S-4" is **not** approved at this time.
- Representative confirmation samples are to be obtained from all excavation bottom and sidewalls. Analytical data will be reviewed by OCD prior to approval for backfill.
- Submit a form C-141 Final Report and closure report upon satisfactory completion of project.
- Project is to be completed and closure documentation submitted to OCD not later than September 21, 2011. Operator may, for good cause, request an extension of time for completion of the project.

Be advised, OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
